I. GENERAL INFORMATION

A. Purpose

This Request for Proposal (RFP) is for snow plowing and removal, and salting services for EightCAP,Inc. locations for the 2024-25 snow season.

Description of Entity

EightCAP, Inc., hereinafter referred to as EightCAP, is a community action agency which serves Gratiot, Ionia, Isabella, and Montcalm counties in the State of Michigan. EightCAP is a private, nonprofit corporation and has been determined to be exempt from Federal income tax under Section 501(c) (3) of the Internal Revenue Code. Administrative offices are located at 5827 Orleans Rd. Orleans, MI 48865. Other offices are located throughout the service area.

5. Right to Reject

EightCAP is not required to accept the lowest bid and reserves the right to reject any and all bids and/or waive any bid irregularities at EightCAP's discretion based on the interest of EightCAP. This includes the right to award separate contracts for building(s) by area, if deemed in the best interest of EightCAP. Therefore, bidders should clearly note which buildings you are willing to (or not to) service.

6. <u>Small Businesses, Minority Owned Firms, and Women's Business Enterprises</u>

Efforts will be made by EightCAP to utilize small businesses, minority owned firms and women's business enterprises.

An Offeror qualifies as a small business firm if it meets the definition of "small business" as established by the Small Business Administration (13 CFR 121.201).

II. SPECIFICATION SCHEDULE

A. Goods or Services Required

C. Price

The Offeror's proposed price must include per plowing event and per salting event.

D. Billing and Payment

Billing must be itemized to indicate date and time of plowing event and/or salting event, and location of the event.

III. PROPOSAL EVALUATION

A. Nonresponsive Proposals

Proposals may be judged nonresponsive and removed from further consideration if any of the following occur:

- 1. The proposal is not received timely in accordance with the terms of this RFP.
- 2. The proposal does not follow the specified format.

B. Evaluation

Evaluation of each proposal will be based on the following criteria:

C. Review Process

EightCAP may, at its discretion, request presentations by or meetings with any or all Offerors to clarify or negotiate modifications to the Offerors' proposals.

Therefore, proposals should be submitted initially on the most favorable terms, from both technical and price standpoints, which the offeror can propose. EightCAP contemplates award of this bid to the responsible Offeror(s) with the highest total points.

This is the list of general conditions:

- Snow removal shall occur Monday-Friday with every 2" or more snow accumulation.
- Vendor is responsible for clearing all sidewalks and walkways.
- Snow removal will include clearing out all snow off sidewalks and up to all entrances of the buildings.
- Snow removal must be completed as noted to accommodate employee and student arrival.
- EightCAP reserves the right to cancel on school/building closure days, such as holidays, snow days, or power outages. Vendors will be notified by EightCAP.
- Salting to keep ice off parking lot and sidewalks. This may need to be done without plowing. Bids must include pricing for just salting.
- Piling of snow is only permitted in areas specified by EightCAP.
- Vendors are responsible to monitor conditions of the snow removal areas for snow drifts, ice, etc, and respond accordingly.
- Vendors must maintain property and liability insurance (minimum \$1,000,000 per occurrence), and auto insurance (minimum \$1,000,000 per occurrence).
 Certificates of insurance must be provided to EightCAP listing EightCAP as an additional insured with respect to liability coverage for work being performed at EightCAP locations.
- Vendors must invoice monthly and itemize invoices by EightCAP location with date and time of service.
